19. Course Description:

This course covers availability, reliability, and maintainability (ARM) analysis with an emphasis on plant integrity. Topics include system failure prediction, failure rate data, and criticality analysis (FMECAs, fault tree analysis). The course also explores availability modelling, reliability-centred maintenance (RCM), and methods for incorporating ARM into design (e.g., reliability block diagrams, functional block diagrams). Students will study structural reliability, uncertainty in failure predictions, and mean time between failures (MTBF), along with maintenance strategies and equipment criticality assessments. Practical examples and case studies will illustrate the integration of these concepts in improving system performance.
